According to Art. 13 and 14 of the Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation - GDPR)

- The Controller of your personal data is the Foreign Section of the Swedish Bar Association (Sveriges advokatsamfund's Utlandsavdelning) (the "Controller"), being a section of the Swedish Bar Association (Sveriges advokatsamfund).
- Your personal data necessary for the registration to this event: name, last name, e-mail address, law-firm, address, bank data for payments and your accompanying person, shall only be processed for the purpose of enabling you and your accompanying person to take part in a conference organized by the Foreign Section of the Swedish Bar Association, obtain a certificate of attendance valid for lawyer's training (vidareutbildning). If you are an accompanying person, we inform you that the Controller received your personal data from the participant and your personal data shall only be processed for the purpose of your participation in the conference as stated herein. Your image (photos and videos taken during the conference, with or without mentioning your name) will be published in social media, internet site, press release, newsletters of the Swedish Bar Association and its Foreign Section for promotion and documentation of their non-profit activities. You are entitled to oppose to such diffusion of your image informing the Controller and, if possible, the photographer on site. We do not process special categories of personal data, however you may want to avoid certain kind of food and we will let the restaurants know your choices if you tell us on time without giving explanations about your health conditions.
- The legal basis of our processing of your personal data are:
 - the performance of a contract on your participation in the event, Article 6 sec. 1 b) GDPR;
 - the compliance with a legal obligation of the Controller (bookkeeping of payments, issue of receipts), Article 6 sec. 1 c) GDPR;
